



Announcement for the **International North American Deutsch** **Kurzhaar-Prüfung 2020**

From September 24th to 26th 2020 in Big Rapids, Michigan

The NADKC and co-host VCDKK recieved the honor to host the 4th international North American Deutsch Kurzhaar Prüfung

The organziing DKV and hosts NADKC/ VCDKK cordially invite all friends of the Deutsch Kurzhaar to participate. All dogs registered in the Deutsch Kurzhaar Zuchtbuch and fullfilling the following requirements may be put forth to participate:

- Handlers must provide proof of a valid hunting license. Admission requirements (section II - §2 PO IKP):
- The trial is open for all Deutsch Kurzhaar dogs registered in the German or international breed books

These dogs have to have earned a minimum of

- two prize 1's between Derby, Solms or AZP and VGP and
- received an adult breed show rating of at least „SG“.
- Instead of the Solms test, the HZP test may be accepted (test results must be provided) if the dogs have proven work rated equivalent to „very good“ scores in the Solms (very good = 9-11 points, no handler influence)
- Dogs that showed gun sensitivity or other behavioral deficits must not be admitted to the NAKP.
- Foreign dogs, registered in a recognized breed book, may be admitted if they have met all criteria stated above. This admission requirement is decided on by the „Präsidium“ (board of directors, DKV)

Only complete nominations will be accepted including handler/ owner email address via postal mail (including the signature on the form), using the DKV Formblatt; emails and fax submissions will not be accepted.

A copy of the annual hunting license needs to accompany the form.

Hand written forms of missing documents will not be accepted.

Foreign dogs will need to add a copy of: The Ahnentafel, copies of qualifying trials, HD-results proving breedability based on the score. There is no right granted to be admitted to the trial. Depending on total numbers of dogs, a first-come/ first-serve rule may be applied. The DKV may make that final decision.

Health certificate: As for any other trial, Rabies vaccination proof needs to be submitted at sign-up at the trial grounds!

Sign-up and submissions need to be received no later than July 1st 2020. Later submissions cannot and will not be accepted.

Test fee: 175\$ (equivalent to 180 euros). The money can be transferred via check with the submission or wired to:

Please put the dog name on check or wire transfer memo.

The money needs to be submitted or wired in full the day of the July 1st deadline. Including the sign-up fee completes the submission.
